Thanks to all who were able to join us at the UNC-TV studios last month. While there were ten of us there, let's try to crack the twenty mark next year.

Comp Ops has been busy with working through all of the system upgrades. All three physical servers now have all of their new hardware installed and I can turn my attention to creating & configuring all of the virtual machines. (The intent is to have primary & secondary web/database servers and a full set of test servers that is an exact copy of the production servers.) After that starts the work of rebuilding the *Kitty Hawk* site (and my football site) to function on the new servers. Our dropbox for comments (and my home e-mail) will still run from the old servers for a long while, saving me the immediate hassles of rebuilding those functions on the new servers.

In *Trek* news, Larry (Cox) sent me a link to <u>StarTrek.com</u> news about <u>the</u> original (TOS) *Enterprise* being moved to a new home inside the Air and Space <u>Museum</u>. I got another link from the <u>StarTrek.com</u> newsletter that had to be one of the best -- a (little?) girl <u>asked Wil</u> <u>Wheaton about being called a nerd while</u> <u>growing up</u>. Wil's answer to her was terrific and drew a lot of applause.

Brad passed along a web site he'd gotten from someone about a new *Star Trek* production getting started, with a cast that includes some from the "official" series -- including Tuvok and Chekov -- and a few *Trek* cast members in new roles. Check out the <u>Star Trek:</u> <u>Renegades web site</u> for all the details.

This appears to be largely the same group who did the three-part *Star Trek: Of Gods and Men* (now available in its entirety <u>on the web</u>), featuring a lot of TOS time frame characters and some other *Trek* cast members, again in new roles. Turning to NASA news, SpaceX has been fairly visible in the press releases this week. The obvious event was the <u>launch of their third cargo run</u> to the space station. The surprise news was them <u>signing a lease to maintain & operate</u> <u>launch pad 39A</u> at Kennedy Space Center. NASA will still own the pad and nothing was mentioned about SpaceX being able to use the VAB.

NASA ran a <u>prolonged full-power test</u> series of their own Orion capsule. This prepares it for its first (unmanned) test flight late this year -- and for the eventual manned flights to follow.

Another big announcement from NASA this week is the *Kepler* telescope discovering the first earth-sized planet in its star's habitable zone (where water will stay liquid).

In slightly-less recent news was the *Cassini* probe <u>finding evidence for a liquid</u> <u>ocean under the icy crust of Enceladus</u>, one of Saturn's moon. The image on the front cover of this issue shows a NASA illustration of what this could look like.

TWO SHOT – KIRK AND SPOCK

Kirk nods in understanding.

KIRK

Astute evaluation of the facts as usual Spock. Anything else to add?

#### SPOCK

We should proceed with caution, Sir. This could be a Romulan trap, a Trojan Horse of sorts.

#### KIRK

Already crossed my mind, Spock. Let's get there before the Romulans. Best possible speed.

EXT. SPACE – WIDE ANGLE – ENTERPRISE AND ROMULAN SHIP

Enterprise is orbiting the Romulan ship at a distance.

INT. ENTERPRISE – BRIDGE – WIDE ANGLE

Senior staff is at their posts.

## KIRK

Okay people, let's get a complete picture of what

we're dealing with. Reports please.

#### UHURA

No communications at all sir. No response on any channel, not even emergency frequencies. No automatic beacons, distress calls or even an open comm line to Romulan space.

#### KIRK

#### SPOCK

As soon as humans or life forms other than Romulans are detected. Also, even if the Romulan's engines are inactive, the resulting explosion could take out the Enterprise as well.

Kirk shifts his stance and gets closer to Spock.

#### KIRK

#### ON KIRK

He's relieved and appreciative.

#### KIRK

#### EXT. SPACE - ROMULAN SHIP

Ship is motionless and no lighting is visible.

INT. ROMULAN SHIP – BRIDGE – WIDE ANGLE

Transporter effect reveals Spock. When transport is complete, Spock scans with his tricorder for a few beats then activates his communicator.

#### **ON SPOCK**

SPOCK

Spock here. Transport complete. Initial readings confirm our scans.

#### KIRK (v.o.) Crew?

# SPOCK

All dead sir. I'm checking the bridge controls and readouts now.

KIRK (v.o.) Understood; standing by. Kirk out.

#### **NEW ANGLE**

Spock moves from console to console, working quickly. After a few moments he runs his tricorder over several panels, then reactivates his communicator.

#### SPOCK

Spock here, sir. I can not detect any booby traps. King to king's level two.

INT. ENTERPRISE - BRIDGE - WIDE ANGLE

#### KIRK

Mr. Chekov, Mr. Sulu, pick up Dr. McCoy on the way to the transporter. Mr. Scott and the rest of the boarding party will join you there.

Chekov and Sulu jump up and head for turbolift. N.D. Crew persons take their places. Uhura stands and looks at Kirk.

#### UHURA And you sir?

Kirk turns to address her.

#### KIRK

I'm remaining on board and so are you. This could still be a trap. Take the science station and call Palmer to take the comm board. I want you to monitor the Romulan ship for changes in energy outputs or anything else of interest.

INT. ROMULAN SHIP – BRIDGE – WIDE ANGLE

Scott, Sulu, Chekov, McCoy, CONNER and two N.D. Security transport in. Spock moves to greet them, security team pull phasers and begin checking immediate area.

#### SPOCK

#### SPOCK

Mr. Sulu, helm, navigation and flight records. Ensign, check weapons and defense systems for prior use and status. I wish to determine if their demise was related to an attack.

Everyone begins to work immediately.

#### ON MCCOY

He's busy moving from body to body taking many readings.

MCCOY Spock, whatever killed this crew did it fast and efficiently.

SPOCK (o.c.) Specifics?

#### MCCOY

Still working on it. Looks like a virus. I recommend minimum exposure; no more teams. Also, decontamination when we return to Enterprise. I'm taking some samples for evaluation.

#### WIDE ANGLE

#### SPOCK

Noted Doctor.

#### CHEKOV

All weapons off line; no recent use. Screens and shields are down due to power loss, no damage to either one.

SULU

Last helm and navigation is from three days ago.

#### ON SPOCK

He studies the surroundings for a moment.

#### SPOCK

Mr. Sulu; Mr. Chekov, check as many sections of the ship as possible in the next fifteen minutes. I'll be with Mr. Scott in engineering. Doctor McCoy? Status.

#### ON MCCOY

He's examining a body.

#### MCCOY

(working) Go ahead. Your fifteen minute limit is just about right. I'll be transporting back to the Enterprise as soon as I get these samples ready for safe transport.

McCoy rises to face Spock.

TWO SHOT – MCCOY AND SPOCK

MCCOY

This is a nasty bug Spock. The crew died a horrible death. I've never seen anything like it.

McCoy looks terrified.

Off his look...

#### END OF ACT ONE

#### <u>ACT TWO</u>

FADE IN:

EXT. SPACE – ENTERPRISE AND ROMULAN SHIP ARE CLOSE IN SPACE

INT. ROMULAN SHIP – ENGINEERING – WIDE ANGLE

Scott and Conner are working at separate control panels when Spock enters.

SPOCK Mr. Scott, what is your status?

Scott continues working.

#### SCOTT (off console) Well, I think I can have all the systems back on line in an hour.

TWO SHOT – SPOCK AND SCOTT

Spock is surprised by Scott's statement.

#### SPOCK

All systems operational; that is most impressive engineer.

Scott stops his work and turns to Spock, smiling.

SCOTT Aye, most of the systems were just... neglected. SPOCK

Unfortunately you may not be able to complete your work.

#### SCOTT

How's that?

SPOCK

The doctor is concerned for our safety. Can you set the ship's systems on standby until we are able to return?

SCOTT Aye, that's easy enough. The engines should keep for now.

#### NEW ANGLE

Conner leaves his position and stands by Scott.

#### SPOCK

(to Scott) Report back to Enterprise within ten minutes. We are temporarily abandoning this ship.

(to Conner) Continue your investigation until Mr. Scott is ready to leave.

Conner moves off and Spock opens his communicator.

#### ON SPOCK

SPOCK (continued) Spock to Enterprise.

KIRK (V.O.) You're ahead of schedule, something wrong Spock?

#### SPOCK

Indeed Captain. Doctor McCoy is concerned for our safety. It seems the Romulan crew died from a virus. We will be returning in less than ten minutes. Have Mister Kyle monitor the decontamination process upon our return. KIRK (V.O.) Anything else?

#### SPOCK

The Romulan ship is completely serviceable and fully operational.

INT. ENTERPRISE – BRIDGE – ON KIRK

KIRK Could she be taken as a prize?

SPOCK (V.O.) Affirmative Captain, after proper decontamination procedures.

#### KIRK

Very well, let's follow doctor's orders. I'll need a full debriefing upon your return. Kirk out.

INT. ROMULAN SHIP – BIOLOGY LAB – WIDE ANGLE

Sulu is checking the lab records as Chekov enters from behind, unseen.

#### CHEKOV

Didn't you get Spock's recall? We're transporting back, Doctor McCoy says the ship needs to be decontaminated because of a virus.

Sulu reacts visibly and becomes excited.

## SULU

(off console) Look at this! It's a biological research project.
